INTERNATIONAL guidelines, policies, or directions, or if I should suffer some injury, illness, or other circumstance
which in HER INTERNATIONAL's opinion, renders my ability to continue to participate in the Activity desirable or
prudent, then upon HER INTERNATIONAL's request, I shall immediately cease my participation in the Activity and
make immediate arrangements to return home at my own expense (Participant Initial)

. Terms and Conditions

International Volunteer Experience ("IVE")	The combined time, effort and financial contributions of a volunteer towards an HER INTERNATIONAL organized development project. The term "IVE" is synonymous with "Activity".
Participant	The individual who will be contributing their volunteer time, effort and financial contribution to a specified HER INTERNATIONAL organized volunteer experience.
Donation	Any charitable payment made to HER INTERNATIONAL.
Contribution	A donation made to HER INTERNATIONAL towards a Participants "Total IVE Cost".
Program Contribution	A \$500 non-refundable contribution for the purpose of supporting the applicable sustainable development project.
In-Country Costs	The applicable contribution amount required to cover the in-country cost of food, accommodation, and transport expenses.

Total IVE Cost	The sum of the Program, Project and In-Country cost and does not include airfare at any time.
Project	A development project conducted by HER INTERNATIONAL or in partnership with an affiliated host partner or non-profit organization.
Airfare	The participant's flight booking and payment are the sole responsibility of the participant. This cost is not part of the Total IVE Cost.
Lowest Reasonable Expense	The lesser cost of all viable options as determined by HER INTERNATIONAL.

II. Participant Eligibility and Indemnifier for Young Person

Minimum age – The minimum age to participate on an IVE is 16 years old provided the person is accompanied responsible legal guardian. III. IVE Payments and Payment Deadlines

Volunteer contribution payment policies – A \$500 non-refundable Program Contribution, which is applied toward the Total IVE Cost, is due with your application. The balance owing of the Total IVE Cost is due September 1, 2024.

The total combined cost of the \$400 Project Contribution and \$2,300 In-Country Cost covers: direct project donation; program costs; and in-country costs (i.e.: travel destination) of accommodations, most meals, and in-country ground transportation except those expenses incurred during free time. I am responsible for any additional costs I may incur during free or personal time, or for activities that are outside the IVE. HER INTERNATIONAL is not responsible for acts or failures of anyone who provides services to me in connection with its volunteer opportunity. For example, HER INTERNATIONAL is not responsible for any costs I may incur due to delays or problems caused by any travel agent, airline, hotel, foreign government, or the Canadian government.

Payment Deadlines

First Payment – The \$500 deposit is due with a Participant's application to confirm his/her registration with a specified IVE. An application is not complete and the Participant's space cannot be confirmed until the deposit is complete

Final payment – The balance owing for the Participant's Total IVE Cost is by September 1, 2024. This includes the \$400 Project Contribution and the \$2,300 owing for In-Country Costs. The Participant's inability to pay the amount required to cover his/her Total IVE Cost in a timely manner will negate his/her eligibility to participate. Failure to meet these payment deadlines will result in IVE cancellation.

The following items are included as part of the Total IVE Cost for typical "Short-term" IVE's:

Transportation Arrangements all at the Participant's own risk:

- Daily transport to and from the Project site.
- Group ground transfer from the in-country airport (at the final destination) to the Project site upon arrival.
- Group ground transfer from the Project site to the departure airport upon completion of Project.
 Participants with deviated travel itineraries are responsible for any costs incurred. HER INTERNATIONAL may assist in arranging deviated travel needs.

Otherwise the cost for in-country meals consumed apart from the team cannot be reimbursed. The cost of snacks and alcohol is not included. Team Leaders

Extra meal costs that exceed this meal allowance are paid for directly by the Participant. The Participant acknowledges that the Activity will be in a foreign country, and there is always a risk that food consumed by the Participant may include ingredients or pathogens which are not familiar to the Participant's digestive system which may react negatively or poorly to the consumption of such food, and that consequently, the Participant may become ill and require medical treatment which may or may not b readily available.

V. Cancellation & Refunds

Cancellation and refund – If I cancel my IVE for any reason I must notify HER INTERNATIONAL in writing. If I cancel, all Contributions to my IVE are non-refundable. HER INTERNATIONAL will not refund because of my inability to participate according to the scheduled itinerary.

HER INTERNATIONAL may cancel any IVE at any time and may reject an application any time before departure. If HER INTERNATIONAL cancels an IVE, then all Contributions will be fully refunded.

Cancellation Refund Policy – Only in the event a Participant cannot participate due to extenuating circumstances as determined by HER INTERNATIONAL the net amount paid towards the Participant's Total IVE Cost, less any applicable cancellation costs, can be transferred towards any IVE that departs within one year of the departure date of the participant's original trip. This amount must be applied to the Total IVE Cost of any Participant who is not already registered for the applicable IVE. A commitment to a future IVE is required within 30 days of the time of withdrawal and if an application is not completed within this time, the net transferable amount will be re-allocated for charitable purposes. If the recipient of the transferred amount cannot participate or must cancel, no further transfers are possible and funds will be re-allocated towards charitable purposes.

HER INTERNATIONAL may cancel an IVE at any time because of acts of war, terrorism, acts of God, or unforeseen circumstances whereby the Participant's safety and well-being could be jeopardized or the project becomes unworkable. HER INTERNATIONAL also reserves the right to cancel if a minimum of four people have not registered for an IVE within 90 (ninety) days of departure. If HER INTERNATIONAL cancels an IVE the Total IVE Cost will be fully refunded.

VI. IVE Payment Methods

 - 4. Verbal authorization of the card holder if the Participant is not the card holder.

Credit card authorization – If applicable, I authorize HER INTERNATIONAL to automatically charge the applicable amount to my credit card at the applicable time according to the information I have provided on my Volunteer Application and or booking form.

TO RELEASE HER INTERNATIONAL from any claim whatsoever which arises or may hereafter arise on account of any first aid, medical treatment or other services rendered to me by or on behalf of HER INTERNATIONAL ("Treatment"), and to indemnify HER INTERNATIONAL for any cost or expense incurred by HER INTERNATIONAL and its volunteers or organizers to facilitate my Treatment.
